NOTICE OF PUBLIC HEARING

A public hearing will be held Thursday, August 22nd, 2024, at 7am at the Cape Girardeau Public Library, located at 711 N. Clark St, at which time citizens may be heard on the property tax rates proposed to be set, by the Municipal Library District of Cape Girardeau. Immediately following the close of the public hearing, the Board of Trustees hold a special meeting and vote to certify the tax rates for the 2024-2025 fiscal year.

The tax rates shall be set to produce substantially the same revenues, which the budget for the fiscal year beginning July 1, 2024, shows to be required from the property tax. The rates conform to the tax rate ceiling pursuant to 137,073,3 or 137.115 RSMo (depending on the year) as well as any rate revisions required by Article X, Section 22 of the Missouri State Constitution. Each tax rate is determined by dividing the amount of revenue required by the current assessed valuation as provided by Subsection 3 of Section 137.245 RSMo. The result is multiplied by 100, so the tax rate will be expressed in cents per \$100 valuation.
